To provide a quality education to students and continuously upgrade and maintain the standards in the quality of education, training, research and other extensional activities.

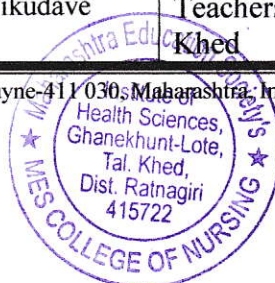
Aims of the IQAC is
