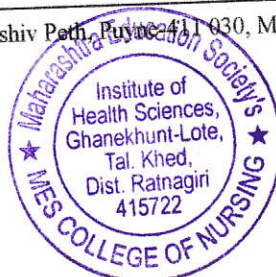

Scope of Agreement;

1. MES COLLEGE OF NURSING and Rotaract Club, Lote plan and conduct community oriented health awareness programmes, outreach and extension activities in and around Ghanekhunt – Lote.
2. Both parties co-operate to conduct different programmes related to national health days.
3. MES COLLEGE OF NURSING conduct community research projects with the support of Rotaract Club, Lote.

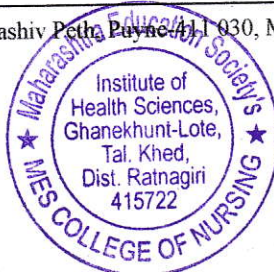

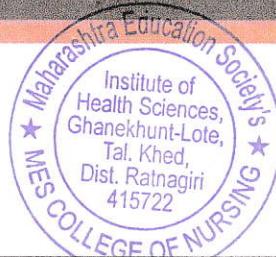
