As per discussion, between the above two mentioned institutions, this MOU is prepared in regard of providing clinical experience to the Nursing Students as per syllabus laid down by Maharashtra State Board of Nursing and Paramedical Education, Mumbai and Maharashtra University of Health Sciences, Nashik; where it is mutually agreed that.....

1. M. E. S. College of Nursing will officially post Nursing Students of MES College of Nursing at Joshi Children's and Eye Hospital, Chiplun regularly over the period of one year starting from 1st May.2022 to 30th Apr .2023.

2. Minimum 10 (Ten) Nursing Students will be posted at a time.
3. Nursing Students will provide care to the patient independently under supervision of Nursing officer of said hospitals
4. Nursing Internees / Students will be posted Between 8 am-8 pm in various departments of the concerned hospitals.

Facilities:

- **Leaves and Day Off:** one day OFF per week will be given to the Nursing Internees/Students.
5. The management of Joshi Children's and Eye Hospital, Chiplun will act as Local Guardian of Nursing Internees /Students as long as they are posted in Joshi Children's and Eye Hospital, Chiplun.
6. All nursing internees/ Students once entered in the training Programme will be under the rules and regulations of Joshi Children's and Eye Hospital, Chiplun. They will have to work under the matron and Senior Staffs appointed by Joshi Children's and Eye Hospital, Chiplun.
7. Monthly performance Record will be kept which has to be judged and looked after by a senior teacher of MES College of Nursing with final authority/ approval of coordinator MES College of Nursing.
8. Monthly follow up meeting will be regularly conducted between students and hospital staff. As well as between both managements,
9. Not with standing any content in this MOU, shall be duty, responsibility and obligation of both the parties to the MOU to complete tenure of Clinical Posting as per schedule.
10. An official letter from MES College of Nursing is required regarding posting number of internees /students and period of posting, a written consent of parents is essential.
11. Any dispute will be solved mutually by the way of meeting as and when needed.
