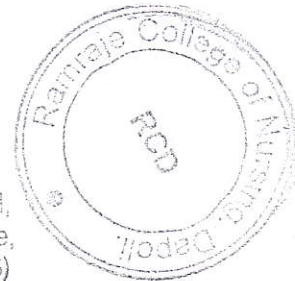

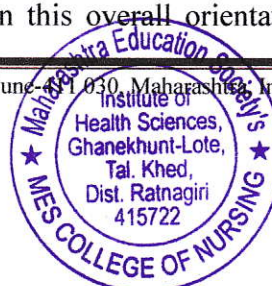
Session: 2nd

In 2nd session explanation about the various method of data collection as like Interview method, Observation method & Questioning method.


Session: 3rd
